From Atlanta

Take I-75 North pass under I-285 to Exit 261, Delk Road. Exit 261 is a two lane exit, stay in the left lane to exit towards Hwy 280/Lockheed/Dobbins Air Force Base. Loop around and cross over I-75 on Hwy 280 South and go about 4 miles. You will pass Dobbins, Lockheed and US 41. After about 4 miles from the I-75 exit, get in the right lane to exit Highway 5 North/Pearl Street. Take the next left onto Garrison and go about 1/2 miles to the Powder Springs Road intersection. Take a left on Powder Springs and go 0.4 miles, at the second traffic light turn right onto Chestnut Hill Road, (before the Eckerds on the corner). Go 1 mile as you pass through 2 stop signs. Laurels Springs is on your left. Turn left into Laurel Springs subdivision, bear left at the first stop sign, turn left again at the next 4 way stop onto Laurel Wood Drive, turn right at the next street, Laurel Wood Court. We are at the back of the small cul-de-sac in a white house with 2 columns and a red door, 566 Laurel Wood Court.

From Roswell

Go West on Marietta Highway, 120/Roswell Road towards Marietta. After you pass the Eastlake Shopping Center with a Marshall's, start getting in the left lane. You will want to make a left turn under the 120 Loop overpass onto the 120 Loop, Marietta Parkway. Follow this through Marietta, passing the Cobb County Civic Center on your left until it intersects with Powder Springs Road. You will see a railroad overpass before the left turn onto Powder Springs Road. Take a left onto Powder Springs Rd. and go 0.4 miles, at the second traffic light turn right onto Chestnut Hill Road, (before the Eckerds on the corner). Go 1 mile as you pass through 2 stop signs. Laurels Springs is on your left. Turn left into Laurel Springs subdivision, bear left at the first stop sign, turn left again at the next 4 way stop onto Laurel Wood Drive, turn right at the next street, Laurel Wood Court. We are at the back of the small cul-de-sac in a white house with 2 columns and a red door, 566 Laurel Wood Court.

From I-75 North (TownCenter Mall)

Take I 75 South to Highway 5. Follow Highway 5 past the Hospital and most of the antebellum homes. At the traffic light before the square, turn right onto Powder Springs Road. Pass the Marietta Conference Center on your right, go about 1 mile and at the traffic light turn right onto Chestnut Hill Road (before the Eckerds on the corner). Go 1 mile as you pass through 2 stop signs. Laurels Springs is on your left. Turn left into Laurel Springs subdivision, bear left at the first stop sign, turn left again at the next 4 way stop onto Laurel Wood Drive, turn right at the next street, Laurel Wood Court. We are at the back of the small cul-de-sac in a white house with 2 columns and a red door, 566 Laurel Wood Court.
